****SNOW POLICY:** Any cancellation due to weather conditions will be recorded on the rink voicemail system (978) 462-8112. If you are unsure of a cancellation please call ahead. Individual cancellation calls will not be made. Freestyle passes will be given out upon request for any session that is cancelled due to reasons beyond our control.

- **Contracts will be accepted until January 8th.**
- **Skaters may not pro-rate the dates when submitting their contract.**
- **Walk-on sessions are available at an additional \$2/contracted price.**

Freestyle ice is available to figure skaters who are receiving private lessons and/or taking part in practice sessions. Skaters may do Dance and Moves in the Field on all sessions offered. **Skaters must be a member of US Figure Skating in order to skate on Freestyle ice (full USFS member or Learn to Skate USA member).** It is recommended that each skater has passed at least the USFS Basic 3 level before they use this ice. Please contact the Skating Director, Nikki Roberts, for information regarding how to begin private lessons. Coaches who are interested in teaching on this ice (and on Public Skating sessions) must be approved by Shamrocks Rink Management. Applications to coach at the Graf Rink may be obtained from Nikki in the front office.

A 50% deposit is due with your registration. **Your final payment is due no later than February 7th. Please note that there will be a 5% finance charge applied to all late balances each week past the due date.** Skaters will not be allowed to contract future sessions until their balances are paid in full. Skaters must check in with Nikki before taking the ice. There will be a limit of 18 contracted skaters allowed on each session.

Skaters will receive one Freestyle pass for any 60 or 50 minute session they contract. Passes may be used as a replacement for any session that you miss throughout the current session, a medial absence make-up or as an extra session. Please turn pass into Nikki when you arrive for your make-up session. Replacement passes will not be given out should you lose your original. Any skater who contracts all 4 sessions is eligible to claim a \$20 credit towards your next Freestyle contract.

Walk-on skaters are allowed and will be charged an additional \$2 per each session skated. Skaters must pay for walk-on sessions before they get on the ice. There will be no exceptions to this rule as bills for walk-on sessions will not be sent. Checks should be made payable to MVSC (Merrimack Valley Skating Club) and, if paying with cash, exact change is greatly appreciated.

MVSC reserves the right to cancel any sessions due to low enrollment. Other than the skating passes (noted above) there will be no refunds or make-ups given. Only medical refunds will be given and a doctor's note must be provided for such refunds. Skaters must use their freestyle passes to make up missed sessions before a medical refund is configured. Skaters will only qualify for a medical refund after 2 consecutive days of your contract have been missed. Your 50% deposit and completed waiver must accompany your registration. The final balance must be paid no later than February 7, 2019. **There will be a 5% finance charge applied to all late balances each week past the due date.** Skaters will not be allowed to contract future sessions or participate in Club activities until balances are paid in full. Skaters are not allowed to switch one session for another or trade spaces with another skater. Freestyle passes will be given out upon request for any session that is cancelled due to reasons beyond our control.

To waive the protection afforded by any statute or law in any jurisdiction whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing the release.
- 5.) If I ignore this agreement and file suite, I will be held responsible for all attorney fees and court costs incurred by SRM and/or MVSC.
